3. All items are sold "As Is, Where Is," without any warranties or guarantees, either expressed or implied.
4. All Sales are Final.
5. Payment is due on the day of sale. Payment shall be made in the form of cash; bank guaranteed cheques; MasterCard or Visa Card; or electronic transfer in SA Rands to **Kensington Bond**
6. Right of admission at Green Acres Centre is reserved.
7. VAT at 14% will be added to the buyer's commission on all lots. The hammer price does not attract VAT unless consigned by a registered vendor. These lots will be clearly indicated in the catalogue by a † symbol.
8. Immediate removal. Any additional removal times will be announced from the podium. Storage fees of R10 per item per day are applicable for items remaining on auction site after removal deadline (10 days after the sale)
